In response to the current COVID-19 situation, CMA and the Board of Directors wanted to send a brief notice in regards to some of the current guidelines which have been issued. We understand that you are most likely aware of these, but wanted to reinforce these for our community to ensure everyone's safety.

- Clean your hands often with soap and water for at least 20 seconds. If soap and water are not readily available utilize hand sanitizer of at least 60% alcohol.
- Avoid close contact with others. Maintain a social distance of at least 6 feet apart. It's great to see everyone going for walks in the neighborhood – but please respect the Social Distancing guidelines for safety.
- Stay home if you are sick. Even if it's just a small cold we want to ensure everyone stays as healthy as possible.
- Cover coughs and sneezes with a tissue or the inside of your elbow. Immediately wash your hands following.
- Clean and disinfect your frequently touched surfaces daily. Some of these may include tables, doorknobs, light switches, countertops, phones, etc.



**IMPORTANT:** Keep your pets on a leash while walking them. While reportedly dogs and other animals are not at risk from the virus, they can carry the virus on them. Several homeowners have called CMA with reports of animals being walked off leash and animals not restrained in their yards. Now is not the time to be taking your animal to the vet if it's bitten by another dog; even worse for a homeowner or child to be bitten and need medical care. For the safety of everyone, please restrain your pets. Homeowners should report an incident to the Colleyville Police Department should they feel threatened by an animal that is not properly restrained.

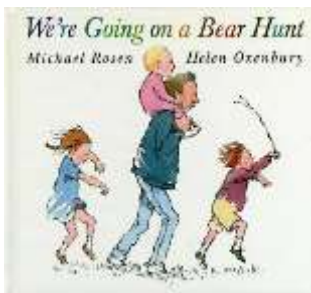
